

## **The Military Occupancy**

First you must understand that Military Law is separate from Civil Law. That's defined in the Military Justice Act of 2016.


Commander in Chief = Military Law

Title 50 Chapter 34 specifically states the President is the ONLY who can terminate a National Emergency.

ACCORDING TO REGULATIONS AND THE UNIFORM CODE OF MILITARY JUSTICE.

Uniform Code of Military Justice = Military Law.

The National Guard is a state-based military force that becomes a part of the reserve components of the United States Army and the United States Air Force when activated for Federal missions.

President Trump specifically Federalized 1,000,000 National Guard for no more than 365 Consecutive days... in Executive Order 13912 (March 27, 2020) and 10 US Code Ch. 1209.

Meaning rotations of units until Operations are complete which means when the National Emergencies are addressed and terminated in which only HE can do because HE declared those.

But always will our whole Nation remember the character of the onslaught against us.

No matter how long it may take us to overcome this premeditated invasion, the American people in their righteous might will win through to absolute victory. I believe that I interpret the will of the Congress and of the people when I assert that we will not only defend ourselves to the uttermost but will make it very certain that this form of treachery shall never again endanger us.

Hostilities exist. There is no blinking at the fact that our people, our territory, and our interests are in grave danger.

With confidence in our armed forces—with the unbounding determination of our people—we will gain the inevitable triumph- so help us God."

FDR gave us the **First War Powers Act**:

The War Powers Acts of 1941 and 1942 granted President Franklin D. Roosevelt extensive powers to support the war effort and provide for the nation's defense.

This bill merely gives the President . . . powers that are necessary to win the war, but powers that should be returned to the Congress when the war has been won.

Via the **Wartime Powers Act of 1941** under Article II, Section 2, Clause 1:

“I ask the Congress to take this action by the first of October. Inaction on your part by that date will leave me with an inescapable responsibility to the people of this country to see to it that the war effort is no longer imperiled by threat of economic chaos.

**In the event** that the **Congress** should **fail** to act, and act adequately, I shall accept the responsibility, and **I will act**.

At the same time that farm prices are stabilized, wages can and will be stabilized also. This I will do.

The **President has the powers**, under **the Constitution** and under **Congressional acts**, to take **measures necessary** to avert a disaster which would interfere with the winning of the war.

I have given the most thoughtful consideration to meeting this issue without further reference to the Congress. I have determined, however, on this vital matter to consult with the Congress . . . .

The American people can be sure that I will use my powers with a full sense of my responsibility to the Constitution and to my country. The American people can also be sure that I shall not hesitate to use every power vested in me to accomplish the defeat of our enemies in any part of the world where our own safety demands such defeat.

When the war is won, the powers under which I act automatically revert to the people—to whom they belong.”

If you take a gander at the Federal Resiliency Act of 2020, signed specifically on December 7, 2020, no coincidence the anniversary of Pearl Harbor... the Act mentions the **National Security Act of 1947**.

The National Security Act of 1947 created the National Military Establishment which became the Department of Defense and NSA of '47 also created the Secretary of Defense position whose roles and duties are outlined in multiple facets of these Executive Orders and U.S. Codes.

Also from the **EO 13848**, first paragraph also alludes to a *Military Occupancy*, of CIC Trump knowing it all from the start:

#### 12.4 THE WHITE FLAG OF TRUCE TO INITIATE NEGOTIATIONS

In the past, the normal means of initiating negotiations between belligerents has been the display of the white flag of truce.

12.4.1 Meaning of the White Flag—a Desire to Communicate. As a legal matter, the white flag, when used by military forces, indicates a desire to communicate with the enemy. The hoisting of a white flag has no other legal meaning in the law of war.

The hoisting of a white flag may indicate that the party hoisting it desires to open communication with a view to an armistice (e.g., to enable forces to collect the wounded) or a **surrender**.
