Not one thing in the 98 pages below is an opinion. I am a United States Army Veteran, Retired, DV. I was a 14S, Air and Missile Defense, holding TS/SCI. I have a Bachelor's degree in Business from The University of Alabama and a Master's degree in Business Administration from Colorado State University, in which I finished with National Academic and Military Honors with a 3.8 GPA.

None of those mean anything except some people always want to know “how do you know this if...” and what follows behind the if is always something like “you weren't a Colonel, so, how could you know this.”

Also, no one needs to know where one served and what we did. War was not meant to be glorified or used as a resume builder. There's also no way for anyone to verify what kind of soldier one was.

Many soldiers join for salary, medical, housing, college, and retirement benefits not only for themselves but spouses and children. The average ASVAB score is a 31 in the Army... if you took a test right now on Military Law, Regulations, History and Constitution, about 75% of the military would be sent home. Many soldiers did not want to be on duty, much less war. But come home and act like freakin' heroes.

We know what we did. Those who did the most, talk the least about their service, missions, and medals. The soldier who talks and posts on social media about “my deployment” is a whoremonger and that’s not what service is about. That too has been misconstrued for the past 30 years or more.

The soldier who’s always talking about “when I was in Iraq” and “when I was deployed”... “I, I, I”... they are missing the point of SERVICE. Service is for the people. The people who are supposed to be doing their part as “we the people” to their Congress. Military is a separate entity once again with our own laws, rules, duties, and regulations. It’s those kind of soldiers who’ve misconstrued service to civilians and when Veterans who know UCMJ, Regs, Codes, Symbols try to talk to the civilians they’ve butchered service to, no wonder we receive the looks, reactions, and comments we do.



I had a Great Uncle, Purple Heart at Normandy... Some of his immediate family had no idea until they opened his cedar chest and found his DD-214 and the Medal. He never talked about those beaches. And he was a Marine. Marines today... are like people who do CrossFit or Vegans... you hear about it every 10 minutes.

All the wars from 1871 to present day are all Corporate Wars... Deep State, The Establishment, and money driven. And when the truth is all revealed, it will be a true great awakening. Corporate Wars are destructive to leadership, morals, standards, honor, and integrity.

It's amazing, it seems the better technology gets, the more lazy people seem to become. I enlisted with a degree. The reason that's important... It means something to Veterans and soldiers. I scored in the upper echelon of the Military, all Branches, on the ASVAB, and chose to enlist instead of going to Officer Candidate School or Warrant Officer School from the start. I enlisted to earn the respect and build experience for when my WOC packet was accepted (as it was), when I became a WO, I would have the respect of the enlisted soldiers I was asking to go into dangerous missions. They would know I'd been there before.

I had 9 Letters of Recommendation all from Colonels and Congressmen. The requirement at that time was only 3. Two months before selection, things took a turn. Those things earned the title Disabled Veteran and Wounded Warrior.

The point with all of the "I" in the above is to outline the fact I had the scores to become a General, but many Americans make comments as if someone who didn't serve in the "amount of time" they think in their minds could know what we know (when they know NOTHING about Military), or being a bucknut specialist couldn't know what a higher rank or officer knows, or not being a "Politician" or Attorney, is the very reason we are where we are. Those are lazy people who won't and don't read themselves, so when they're presented with this much information... they resort to condescending comments and attitudes.

Which is why we are where we are and it's also why the Military had to step in. The **biggest misperception** to many, is the Military is a part of Government. That’s false. We are a separate entity. We have our own Law - the Uniform Code of Military Justice, Regulations, Branch Regulations, Symbolism, Branch Symbolisms, Roles and Duties.

Therefore the Military can act on their own. They can act without Congress. The Founders established this. When I say “the Military,” that means the Generals.

President Trump laid down code language on his 2016 campaign that was a “conspiracy theory” for over 60 years until then... This is a well known fact in the Military, over 200 Generals have said, “never again will we let happen to this Country what happened during JFK, when we get the chance to take over this Country and restore it back to the Republic.”

So help me **God**." (Title 10, US Code; Act of 5 May 1960 replacing the wording first adopted in 1789, with amendment effective 5 October 1962).

Solemnly definition = serious and dignified.

Notice it's also very specific on structure. It says:

SUPPORT first then **DEFEND**.

Definition of **Support**:

1. To bear the weight of, especially from below; keep from falling, sinking, or slipping.
2. To bear or hold up (an amount of weight).
3. To keep from weakening or failing; give confidence or comfort to.

Definition of **Defend**:

1. To make or keep safe from danger, attack, or harm.
2. To engage in or be prepared to engage in battle to prevent (a population or area, for example) from being captured or occupied by an enemy.
3. To attempt to prevent the opposition from scoring while playing in or near (a goal or area of a field, for example).

Imagine that... who knew every word meant something? Why do we even have words if they do not mean anything?

According to **REGULATIONS** and the UCMJ.

Imagine that... What Regulations? LOL

And what is the Uniform Code of Military Justice? HAHA

I'd SURE love to see the civilians I know, who've NEVER served, who have called me and other Veterans crazy for simply laying out LAW and ORDER, join the Military, and tell ANY Commander or one in charge, the UCMJ is a crock of crap...

That would be EPIC and thoroughly satisfying.

So where did the UCMJ come from?

The very first Military Branch was founded **June 14**, 1775, the United States Army. The Revolutionary War started April 19, 1775.

The Founders fought two months before establishing the Nation's first Branch of Military as they stated, "we need a swift army on the ground and army on the water." The Navy was founded shortly after on October 13, 1775, then the Marines, November 10, 1775.

The **Uniform Code of Military Justice** aka Military Law was passed on **June 30, 1775**, with 69 Articles of War to govern the conduct of the Continental Army.

The Declaration of Independence was APPROVED on July 4, 1776, but was written in **June 1776**.

However, no one ever stops to think that the war was one year in... and the Americans were already declaring VICTORY via this Document when the war did not end until **1783**.

There's absolutely **NO COINCIDENCE** the United States Flag was sworn into Congress, **June 14, 1777**.

No coincidence that 50 days later... The **First** United States Flag ever flown, took flight at Fort Stanwix aka Fort Schuyler (at that time) on August 3, 1777, and 3 days later, was in one of the BLOODIEST battles in the Revolutionary War during the Saratoga Campaign which started in **June 1777**. No coincidence Fort Schuyler is now the Fort Schuyler **Maritime** College.

At the Battle of Baltimore in 1814, Major George Armistead ordered "*a flag so large that the British would have no difficulty seeing it from a distance.*" It measured 42' × 30' and was known as the "Great Garrison Flag" and the "Star Spangled Banner Flag."

The resistance of Baltimore's Fort McHenry during bombardment by the Royal Navy inspired Francis Scott Key to compose the poem "**Defence of Fort McHenry**," which later became the lyrics for "**The Star-Spangled Banner**."

This is **nothing short** of a Monumental, Historical, and Biblical **Covert Operation** everyone has been witnessing and I'm glad to have played a small part in it while active duty 2012-2015 and still a part of the fight beyond my service.

Here's what you have to understand:

We have our OWN Law in the Military = the Uniform Code of Military Justice. We have our own regulations, language, symbolisms, and terminology. It's a separate law, duty, role, and life from yours. The Constitution is the highest law in the land protected by the Military. The Founders made it that way.

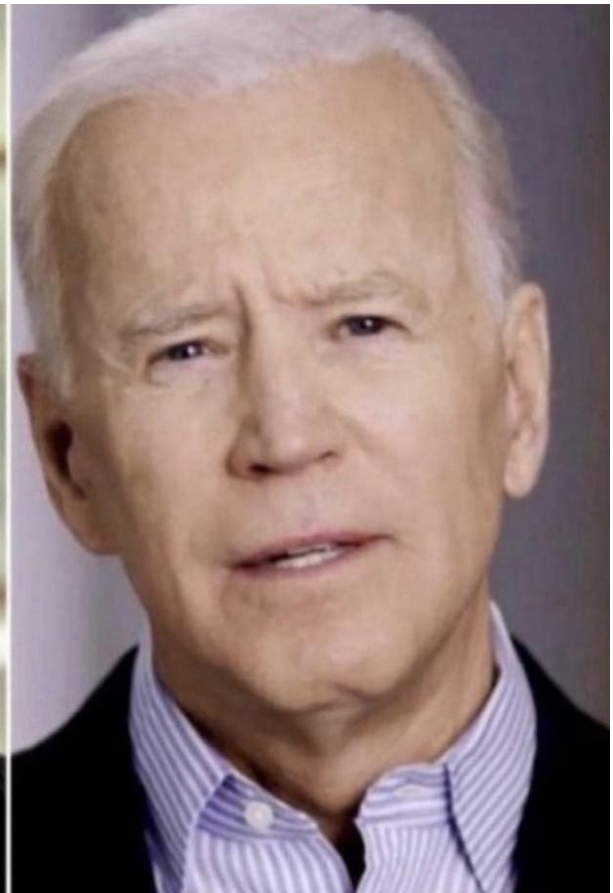
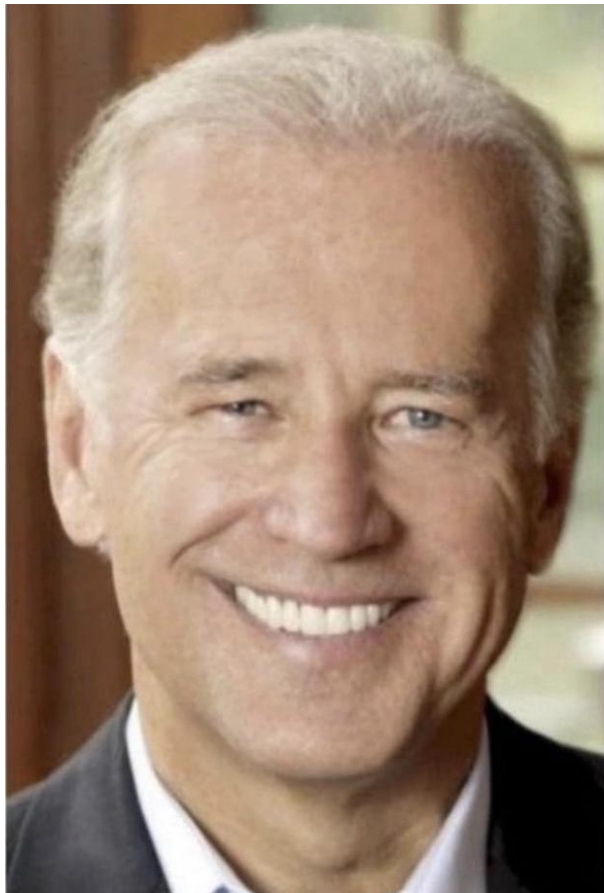

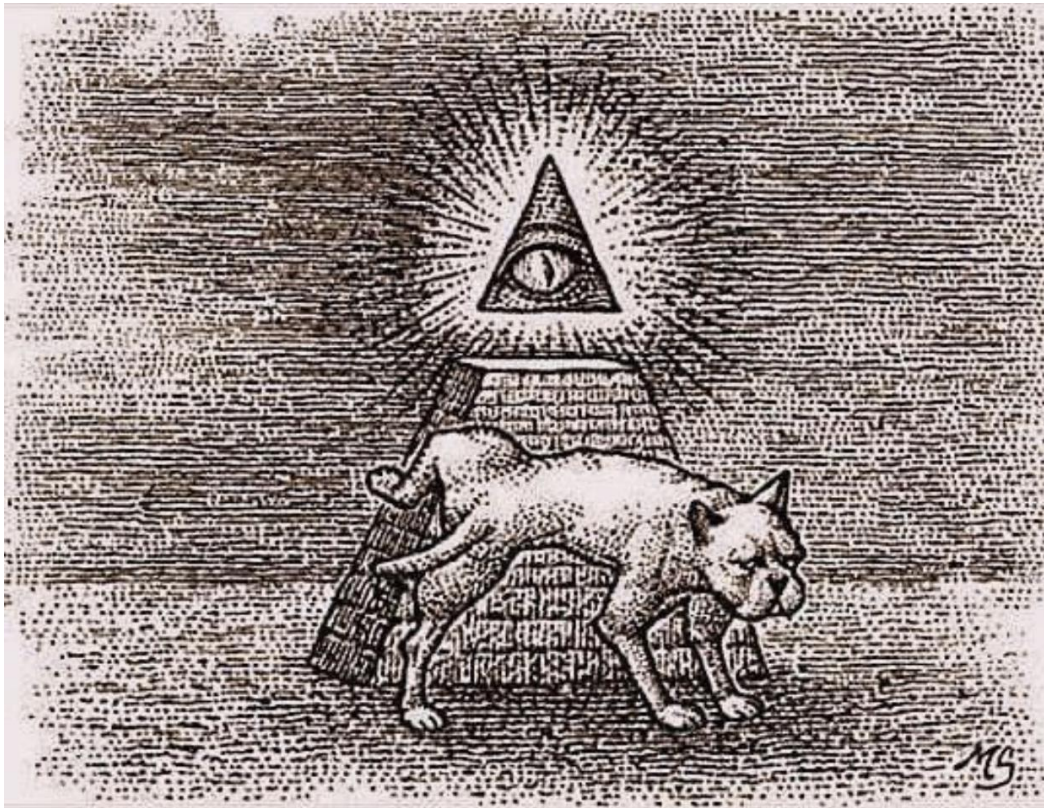

The **Executive Orders** from January 20, 2017, to January 20, 2021, Military Law, Military Regulations, Military Operations, Military Optics, Military Code, Presidential Emergencies (PEADs), National Emergencies, Presidential Acts, via the Constitution, U.S. Law and U.S. Codes...

hold ALL of the answers to this Biblical, Monumental, Historical, Covert Operation.

First and foremost, it needs to be made clear, there's a difference in Constitutional Law prior to 1871, and post 1871.

There's plenty of career Politicians, Lawyers, and people who misconstrue, butcher, and twist the Constitution via reverse psychology and many other tactics or just straight up ignorance to fit their agenda and narrative... and **THAT** has been the downfall and problem with the United States and **THAT** is why the Military will once again save the day as we always have done and will do.

The general misconception is that any statute passed by legislators bearing the appearance of law constitutes the law of the land. The Constitution is the supreme law of the land, and any statute, to be valid, must be in

agreement. It is impossible for a law which violates the Constitution to be valid. This is succinctly stated as follows: "**All laws which are repugnant to the Constitution are null and void.**" Marbury vs. Madison 1803, 5 U.S. (2 Cranch) 137, 174, 176.

Here's how the Military is in control and President Trump is still in charge according to LAWS and ORDERS:

First thing you need to know is President Trump's monumental Executive Order 13848 signed in **2018**. Inside that Order **4 events** were outlined:

1. Declared a National Emergency. By Federal Law, National Emergencies must be addressed by that Congress. It was **not** addressed. Covid-19 was not mentioned until February 4, 2020, at the State of the Union Address, FIRST by President Trump, so, how did he know to issue a National Emergency in September 2018 to activate on November 3, 2020?

2. Declared Maritime Law. He specifically put the date of November 3, **2020**, as the activation date of Maritime Law on September 12, **2018**. If there's no such thing as Voter Fraud, which first became a topic in the 'news' in December 2020, then how did President Trump know to put the specific date of November 3, **2020**, inside the September **2018** Executive Order? #MilitaryIntel

3 and 4. The Election Fraud Committee and Secretary of State. President Trump specifically put the dates of activation in which they would **report**. 45 days after November 3, 2020, which was **January 2, 2021**, and 45 days after that... which is **March 3, 2021**.

President Trump and FEMA declared **two** more **National Emergencies** in 2020 that also were also **never** addressed by that Congress.

Which is why on November 3, 2020, President Trump issued a **Presidential Emergency**, known as a **PEAD**, a **Presidential Emergency Active Document**. "Upon proclamation by the President that there exists war or a threat of war, or a state of public peril or disaster or other national emergency..."

Closing of Facilities; Government use of Facilities:

"The President, if he deems it necessary in the interest of the national security and defense..."

Why did the National Guard and Reserves place Fences (facing inwards = prison) around the Capitol building? And why did the "Biden Administration" build REPLICAS of the press room, oval office, etc.?

Only **3 pieces** of artillery; 2 firing, one for misfires. The firing of **three** rifle volleys (rounds) over the **graves** of **fallen armed forces members** and **political leaders** can be traced to the European dynastic wars, when fighting was halted to **remove the dead and wounded**.

This is not a 21-gun salute, nor any other type of "gun salute." The firing team can consist of any number, but one usually sees a team of eight, with a noncommissioned officer in charge of the firing detail. Whether the team consists of three or eight, or ten, each member fires three times (three volleys).

The number of guns does not mean it's not official. It's the numbers fired that matters. "Biden" received an 13 gun salute, this means via gun salute regulations:

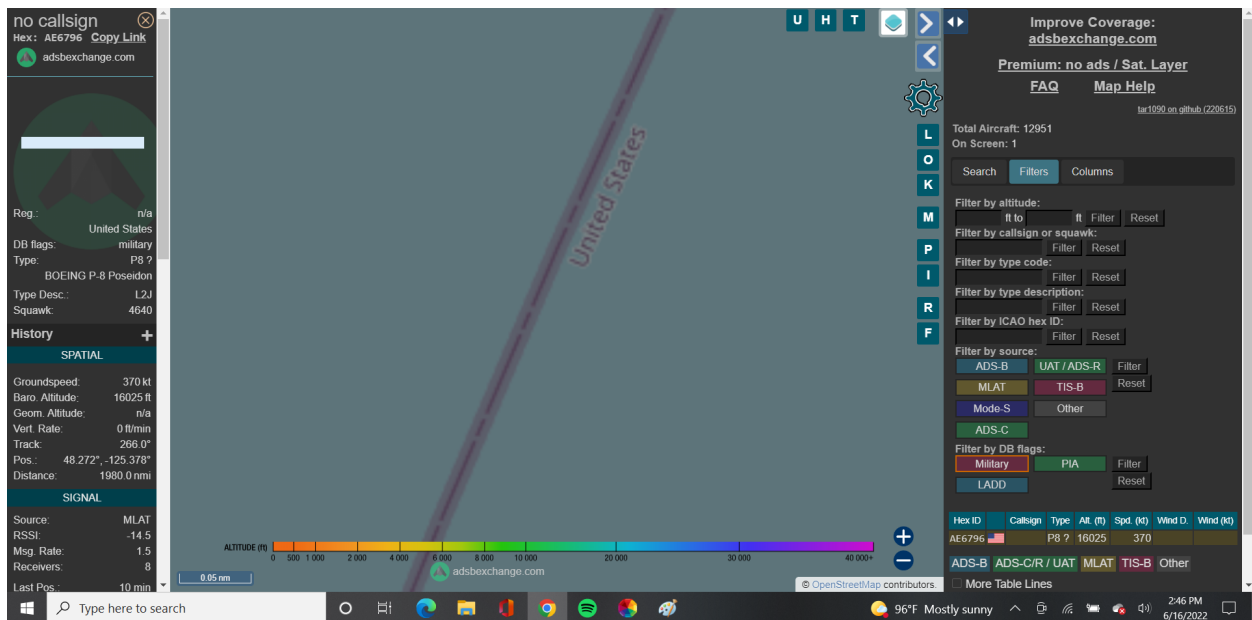

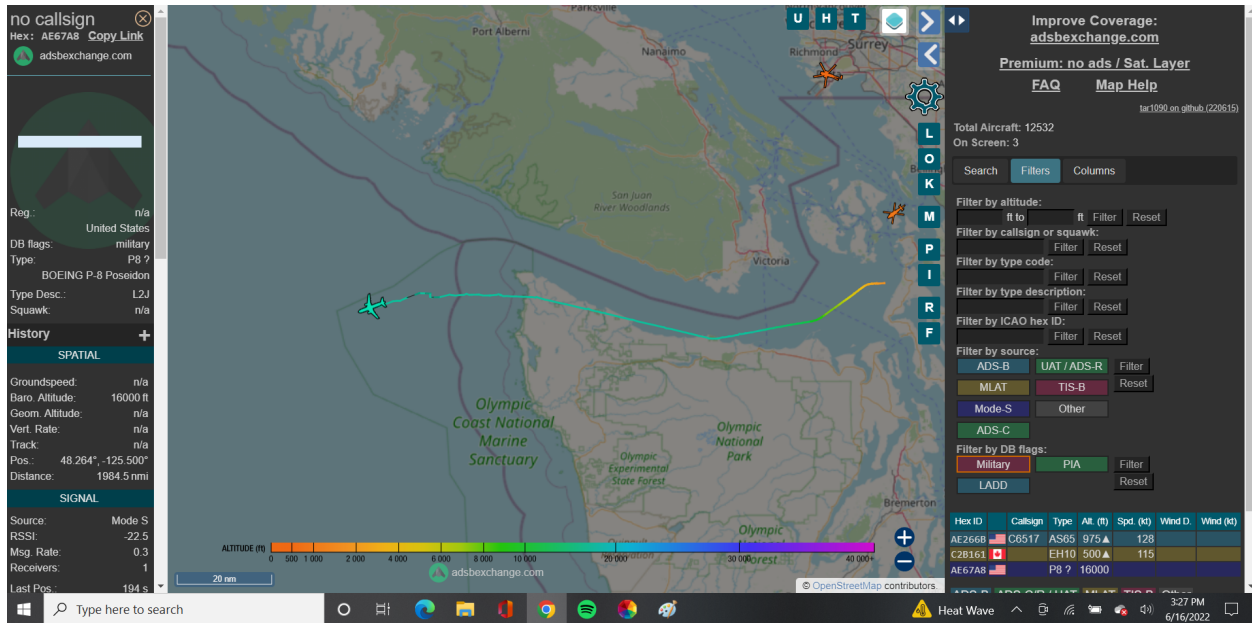

That first faint gray line close to the shoreline of Washington state, is the Maritime Border for the state of Washington.

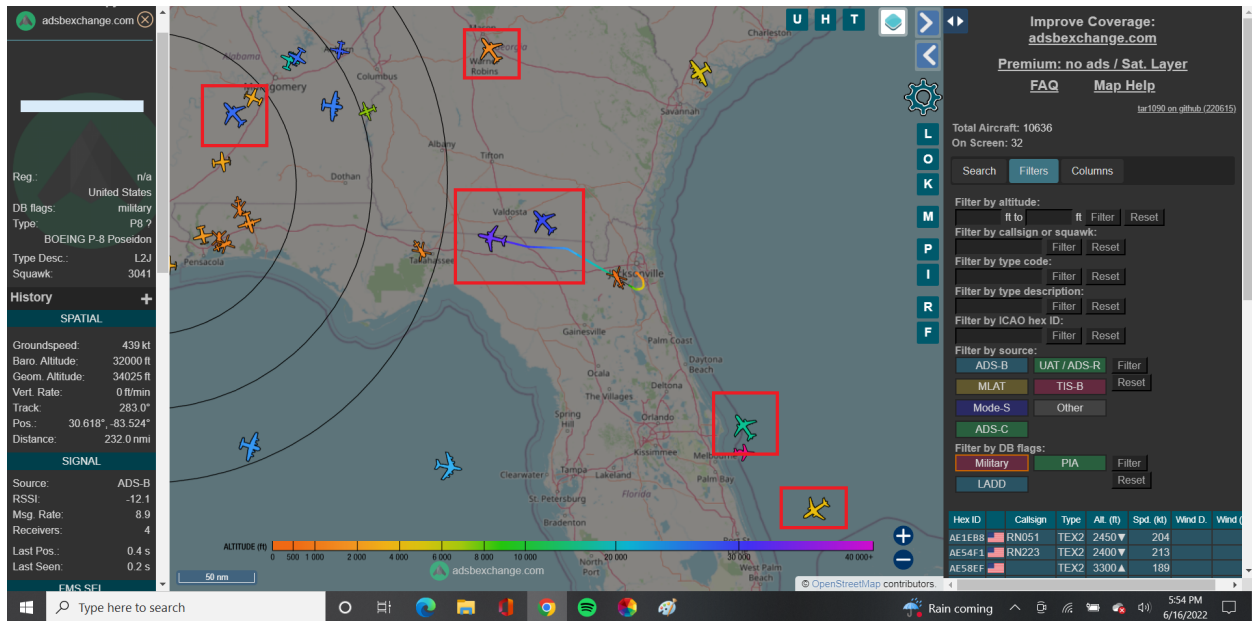
That darker gray line is the United States Maritime Law border.



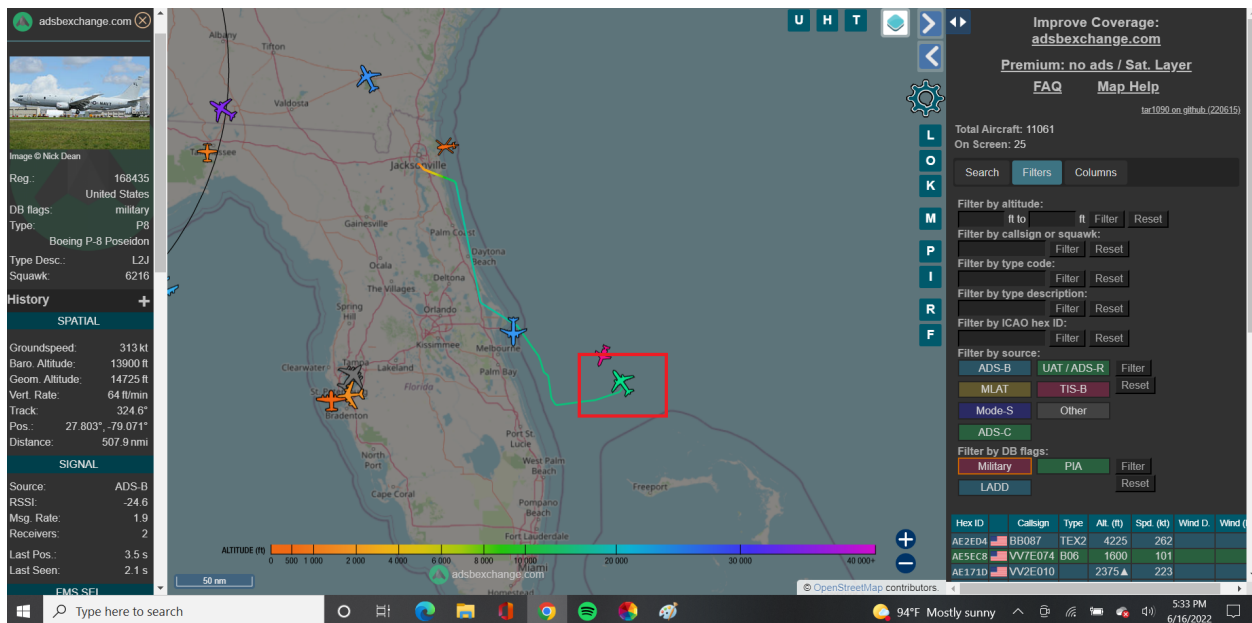

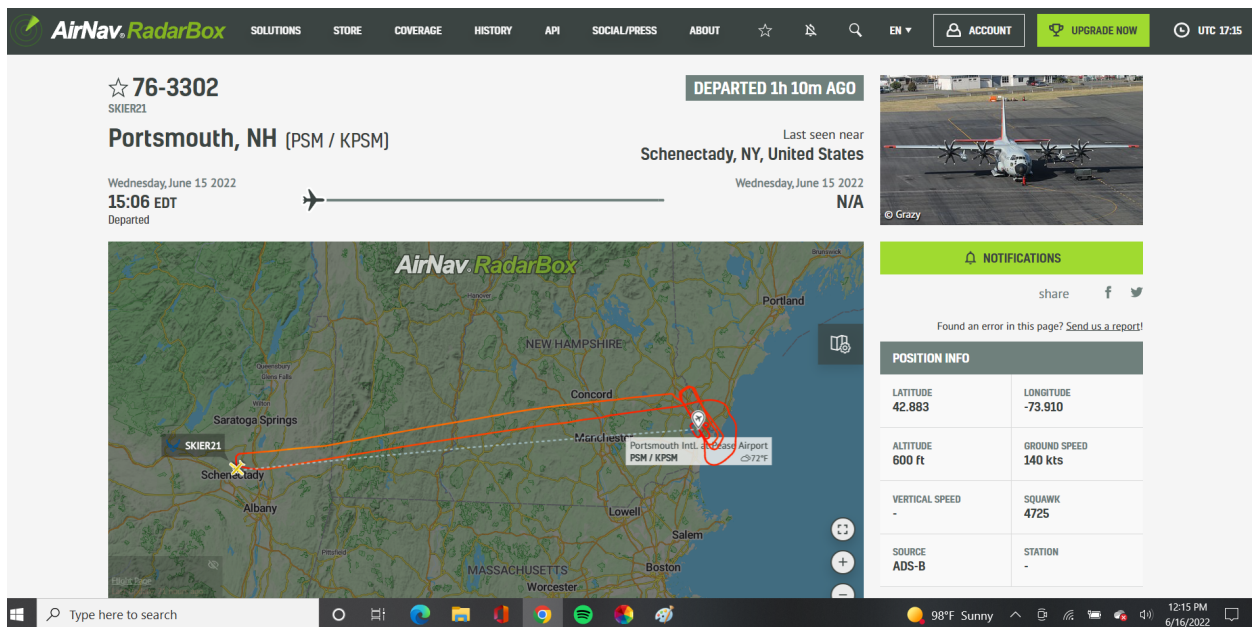

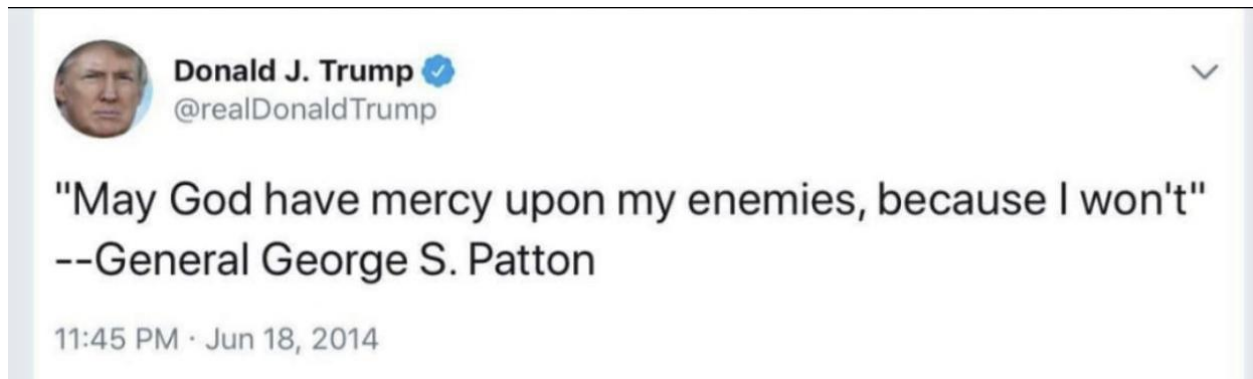

Under **American Maritime Law**, the ship is personified to the extent that it may sometimes be held responsible under circumstances in which the shipowner himself is under no liability.

The classic example of personification is the “compulsory pilotage” case. Some state statutes impose a penalty on a shipowner whose vessel fails to take a pilot when entering or leaving the waters of the state.

Since the pilotage is this compulsory, the pilot’s negligence is not imputed to the shipowner. Nevertheless, the vessel itself is charged with the pilot’s fault and is immediately impressed with an inchoate maritime lien that is enforceable in court.

Maritime liens can arise not only when the personified ship is charged with a maritime tort, such as a negligent collision or personal injury, but also for salvage services, for general average contributions, and for breach of certain maritime contracts.

In a proceeding in rem, the vessel, cargo, or freight can be arrested and kept in the custody of the court unless the owner obtains its release by posting a bond or such other security as may be required under the applicable law or as may be acceptable to the plaintiff.

More frequently, however, the owner will post security to avoid a threatened arrest, and the property never has to be taken into custody. When the judgment is for the plaintiff in a proceeding in rem, there will be a recovery on the bond or other security if the owner of the property does not pay; or, if security has not been posted, the court will order the property sold, or the freight released, in order to satisfy the judgment.

The sale of a ship by an admiralty court following a judgment in rem divests the ship of all pre-existing liens—and not merely those liens sought to be enforced in the proceeding in rem.

By way of contrast, the holder of an in personam judgment against a shipowner can, like any judgment creditor, have the ship sold in execution of the judgment; but such a sale, unlike the sale under an admiralty judgment in rem, does not divest existing liens; the purchaser at the execution sale takes the ship subject to all such liens.

Thus, an in rem proceeding has decided advantages over a proceeding in personam in a case in which the shipowner is insolvent.

Efforts have been made from time to time to increase the security value of ship mortgages, in order to encourage lending institutions to finance vessel construction, but these efforts have not been very successful, largely because of differences in national laws respecting the relative priorities of mortgages and maritime liens. (Under general maritime law there is a complex hierarchy of maritime liens; that is to say, in a proceeding that involves distribution of an inadequate fund to a number of lien claimants, liens of a higher rank will be paid in full in priority over liens of a lower rank; and in most countries a ship mortgage ranks lower than a number of maritime liens.)

Attempts were made to harmonize some of these conflicts by international conventions signed in 1926 and 1976, but the first failed to win widespread support and, as of the end of 1983, the second had been ratified by only half of the signatories required for the convention to enter into force.



Evergrande (worth \$300 billion) started defaulting. *Evergrande* is one of the biggest and most recent stories of what's taking place through these sanctions and orders. Evergrande only has their hands in the global housing market, that's all.

Mark Zuckerberg started a weekly and steady dumping of assets in which he has sold \$25 million in stocks to this present day. Facebook's recent "glitch" and 6 hour shutdown was not coincidence.

stocksharks Jeff Bezos saw US\$13 billion of his fortune melt away after Amazon.com Inc.'s results left investors disappointed.

Shares of the e-commerce company slumped more than 8 per cent in early New York trading on Friday as it reported a quarterly loss and the slowest sales growth since 2001. If the loss persists, Bezos's net worth will drop to around US\$155 billion, according to the Bloomberg Billionaires Index. At his peak last year, he was worth more than US\$210 billion.

Bezos, the world's richest person after Elon Musk, was already the fourth-biggest wealth loser this year, with his fortune dropping by US\$23 billion through Thursday, according to the Bloomberg Billionaires Index.

Amazon is contending with higher labor costs following a hiring binge during the pandemic and a surge in inflation that may hold back sales. The company posted a net loss of US\$3.8 billion in the quarter ended March 31, compared with profit of US\$8.1 billion in the same period last year.

Ever since January 11, 2021, there's been over **1,300** CEOs resign. There's something in the news every single day showing CEOs resigning, being arrested, busted, etc.

TITLE I—NATIONAL QUANTUM INITIATIVE

SEC. 101. NATIONAL QUANTUM INITIATIVE PROGRAM.

(a) **IN GENERAL.**—The President shall implement a National Quantum Initiative Program.

(b) **REQUIREMENTS.**—In carrying out the Program, the President, acting through Federal agencies, councils, working groups, subcommittees, and the Coordination Office, as the President considers appropriate, shall—

(1) establish the goals, priorities, and metrics for a 10-year plan to accelerate development of quantum information science and technology applications in the United States;

(2) invest in fundamental Federal quantum information

The National Quantum Initiative Act (NQI Act) was signed into law by President Trump on December 21, 2018 “to accelerate quantum research and development for the economic and national security of the United States.” The NQI Act authorizes the National Institute of Standards and Technology (NIST), the National Science Foundation (NSF), and the Department of Energy (DOE), to strengthen QIS Programs, Centers, and Consortia. The NQI Act also calls for a coordinated approach to QIS Research and Development (R&D) efforts across the United States Government, including the civilian, defense, and intelligence sectors. To guide these actions, the NQI Act legislates some responsibilities for the National Science and Technology Council Subcommittee on Quantum Information Science (SCQIS), the National Quantum Coordination Office (NQCO), and the National Quantum Initiative Advisory Committee (NQIAC). Recognizing that QIS technologies have commercial and defense applications, additional authorization for QIS R&D is legislated by the National Defense Authorization Act. Civilian, defense, and intelligence agencies all have a long history of investments in QIS, and have a stake in future QIS discoveries and technology development. The National Quantum Initiative now provides an overarching framework to strengthen and coordinate QIS R&D activities across U.S. Departments and Agencies, private sector industry, and the academic community.

The SAME “Q” Obama called “conspiracy theorizing” and the “media” has now jumped on.

Simply displaying their crimes to the world as President Trump said they would.

“For this reason, the national emergency declared on **September 12, 2018**, must continue in effect beyond September 12, 2021. Therefore, in accordance with section 202(d) of the **National Emergencies Act (50 U.S.C. 1622(d))**, I am continuing for 1 year the national emergency declared in Executive Order 13848 with respect to the threat of foreign interference in or undermining public confidence in United States elections.”

Why would a “President” extend the Executive Order (highest law of the land) which outlines a National Emergency, Election Fraud Committee, and Maritime Law all in one?

Let's look at 50 United States Code 1622:

(d) Automatic termination of national emergency; continuation notice from President to Congress; publication in Federal Register

Any national emergency declared by the President in accordance with this subchapter, and not otherwise previously terminated, shall terminate on the anniversary of the declaration of that emergency if, within the ninety-day period prior to each anniversary date, the President does not publish in the Federal Register and transmit to the Congress a notice stating that such emergency is to continue in effect after such anniversary.

(Pub. L. 94–412, title II, §202, Sept. 14, 1976, 90 Stat. 1255; Pub. L. 99–93, title VIII, §801, Aug. 16, 1985, 99 Stat. 448.)

TO THE CONGRESS OF THE UNITED STATES:

Section 202(d) of the National Emergencies Act (50 U.S.C. 1622(d)) provides for the automatic termination of a national emergency unless, within 90 days prior to the anniversary date of its declaration, the President publishes in the Federal Register and transmits to the Congress a notice stating that the emergency is to continue in effect beyond the anniversary date. In accordance with this provision, I have sent to the Federal Register for publication the enclosed notice stating that the national emergency with respect to Sudan declared in

Executive Order 13067 of November 3, 1997, is to continue in effect beyond November 3, 2021.

Sudan made strides in its transition toward democracy since 2019, but the military takeover of the government and arrest of civilian leaders now threaten those positive gains. The crisis that led to the declaration of a national emergency in Executive Order 13067; the expansion of that emergency in Executive Order 13400 of April 26, 2006; and the taking of additional steps with respect to that emergency in Executive Order 13412 of October 13, 2006, Executive Order 13761 of January 13, 2017, and Executive Order 13804 of July 11, 2017, has not been resolved. The situation in Darfur continues to pose an unusual and extraordinary threat to the national security and foreign policy of the United States. Therefore, I have determined that it is necessary to continue the national emergency declared in Executive Order 13067, as expanded by Executive Order 13400, with respect to Sudan.

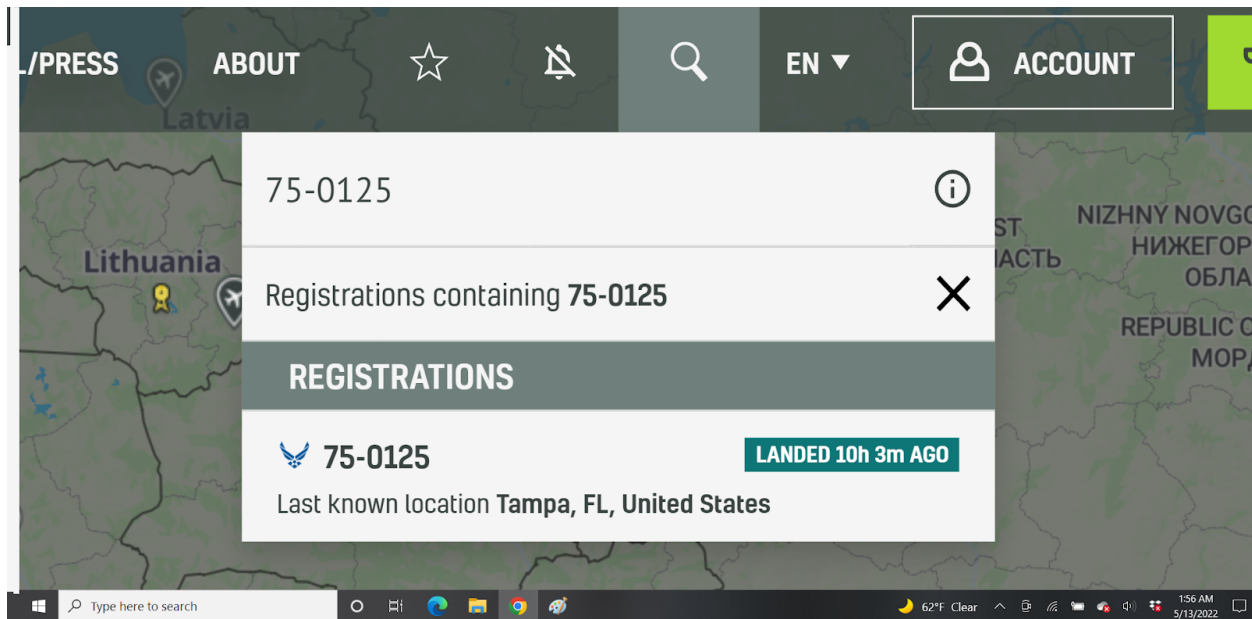

Executive Order 13823 of January 30, 2018

Protecting America Through Lawful Detention of Terrorists

By the authority vested in me as President by the Constitution and the laws of the United States of America, it is hereby ordered as follows:

Section 1. Findings. (a) Consistent with long-standing law of war principles and applicable law, the United States may detain certain persons captured in connection with an armed conflict for the duration of the conflict.

(b) Following the terrorist attacks of September 11, 2001, the 2001 Authorization for Use of Military Force (AUMF) and other authorities authorized the United States to detain certain persons who were a part of or substantially supported al-Qa'ida, the Taliban, or associated forces engaged in hostilities against the United States or its coalition partners. Today, the United States remains engaged in an armed conflict with al-Qa'ida, the Taliban, and associated forces, including with the Islamic State of Iraq and Syria.

(c) The detention operations at the U.S. Naval Station Guantánamo Bay are legal, safe, humane, and conducted consistent with United States and international law.

(d) Those operations are continuing given that a number of the remaining individuals at the detention facility are being prosecuted in military commissions, while others must be detained to protect against continuing, significant threats to the security of the United States, as determined by periodic reviews.

(e) Given that some of the current detainee population represent the most difficult and dangerous cases from

- The Pentagon, alongside President Donald Trump, is planning for nearly \$500 million in new construction at the Guantanamo Bay Naval Base, according to [the Miami Herald](#).
- The base would see funds directed toward a \$250 million, five-bed hospital; a \$124 million Army barracks; and a \$100 million skeletal structure to support a tent city for up to 13,000 migrants and housing for 5,000 U.S. forces.
