3 and 4. The Election Fraud Committee and Secretary of State. President Trump specifically put the dates of activation in which they would report. 45 days after November 3, 2020, which was January 5, 2021, and 45 days after that... which is **March 3, 2021**.

It further authorizes the president, after such a declaration, to block transactions and freeze assets to deal with the threat. In the event of an actual attack on the United States, the president can also confiscate property connected with a country, group, or person that aided in the attack.

The IEEPA falls under the provisions of the **National Emergencies Act (NEA)**, which means that an emergency declared under the act must be renewed annually to remain in effect.

National Emergencies Act:

The Act empowers the President to activate special powers during a crisis but imposes certain procedural formalities when invoking such powers. The perceived need for the law arose from the scope and number of laws granting special powers to the executive in times of national emergency. Congress can terminate an emergency declaration with a joint resolution enacted into law.

At the Battle of Baltimore in 1814, Major George Armistead ordered "a flag so large that the British would have no difficulty seeing it from a distance." It measured 42' × 30' and was known as the "Great Garrison Flag" and the "Star Spangled Banner Flag."

The resistance of Baltimore's Fort McHenry during bombardment by the Royal Navy inspired Francis Scott Key to compose the poem "Defence of Fort McHenry," which later became the lyrics for "The Star-Spangled Banner."

So, choosing to kneel or sit down, not taking your hat off, or putting your hand over your heart... is a <u>disgrace</u> to all service members, but especially those who gave their life for you to live yours. The United States Flag represents the **MILITARY FIRST**... not the States.

(3) the President is unable with the regular forces to execute the laws of the United States; the President may call into Federal service members and units of the National Guard of any State in such numbers as he considers necessary to repel the invasion, suppress the rebellion, or execute those laws. Orders for these purposes shall be issued through the governors of the States or, in the case of the District of Columbia, through the commanding general of the National Guard of the District of Columbia.

President Trump put into his September 12, 2018, Executive Order, a National Emergency that went unaddressed (violation of Congress and Law) and the activation of Maritime Law on November 3, 2020. *How* did he know to put those with the date of November 3, **2020**, to ACTIVATE in an Executive Order (Automatic Law) in September **2018**?



During these conflicts, fighting was commonly halted on the battlefield to clear the dead. Once the dead were removed, three rounds would be fired to indicate that fighting should resume.






The only way National Guard Units operate in other states or across state lines is FEDERAL ACTIVATION.


They do NOT operate in other states for "training purposes."








